

#### Comments - Day 1: Taking Stock and Bolstering the Partnerships

- Parts of the day were hard to follow.
- It was good

- Sessions too short
- I hope Denmark really listens to what was shared
- It would have been great to hear from a broader set of CtA partners/stakeholders about what they consider key achivements and challenges
- During many of the sessions, it seemed like partners (particularly the States) spoke about their own individual accomplishments and not those of Working Groups or the full partnership. While it is good to understand efforts taken by individual groups, but when taking stock of the actions of the collective, individual efforts should take a backseat to collective. Also, we should concentrate on gaps and forward momentum, as opposed to previous efforts or commitments made.
- - Great facilitators and loved the summary of achievements by Lena! Norway's presentation was more about Norway than the States/Donors Working Group, which set an unfortunate tone.
- Way too much jamboard made folks less active less engaged
- Some parts of the session was poorly moderated which made me loose concentration.
- The joint work framework is well developed, but there is no unified and realistic mechanism for the Middle East region, so that organizations contribute within their national framework as intermediate outputs to the regional output, whether from reports or monitoring activities and case studies. I made it clear in the sessions the importance of the coalition working to support the organizations involved through funds from donors subject to submission and competition from the rest of the partner members in a call to action to move to the phase of monitoring commitments in the road map.

- All days very well facilitated. I just was not sure what purpose for meeting, what
  priorities we agreed, and what next steps. I was confused about who is leading this
  strategy.
- I really enjoyed the individual sessions because it allows individual concerns to be raised to a more focused level in order to unearth the bottlenecks of the GBV issue.

#### Comments - Day 2: Identifying and Agreeing Priorities for Collective Action

- I look forward to seeing the next steps that will be proposed by the Steering Committee and hopefully agreed by WGs and across WGs. Our priorities will only means something if we put work behind them now that the meeting has closed.
- Great facilitators again! Really helpful to get the accountability element brought in by Erin, as well as the look back to what CtA was about originally
- What did we decide?
- It was interactive and issues discussed were pressing and important aspects for a collective action
- I think one of the points is prioritizing the needs of the frontier women, which is quite adequate.
- Holistic management of cases of GBV, socio-professional reintegration, development of stakeholder maps, positioning of stakeholders in the design of strategic plans, etc.

The way in which the Norwegian representative treated the (female) facilitator when he'd gone over time was unacceptably rude particularly in a forum about gender equality and GBV.

- We wish for frequent meetings, as well as to allow women activists and representatives of civil society organizations, especially women, to be in the Arabic language so that we can convey our voice

- The timeframe for various presentations would have to be increased as presentations are usually too short
- In general, three days is way too long for a virtual annual meeting. Some of the sessions were hard to follow, especially those with less experienced moderators.
- Thanks for all the fantastic work to pull this together- the intensity of the prep really came through. I would've appreciated more decision-oriented sessions and conversations about the future of the partnership, but look forward to more conversations going forward.
- Generally WAAAAAAY too much in the agenda (this is why I ranked format as poor). Would have been much better to have many fewer topics and allow actual discussion and not have to keep cutting everyone off. Every time it felt like we were starting to get into a topic that needed real discussion, we were stopped b/c of time constraints. Unclear how that's helpful for the future. Also too many jamboards without real discussion of the points raised on them. Please please please next time don't overload the agenda so much. Esp if the event is virtual, perhaps have 2 annual meetings that each have fewer agenda items than trying to race thru everything in a few hours.
- To publish a list of interested donors in our region in order to communicate with them (the Middle East region)

- The design of the meeting needs to be done externally to ensure the agenda is strategic this meeting was a checkbox exercise
- It was a lot of jam boards, definitely miss the in person event, cannot be replaced online. The participation was active but whenever we delved into issues the session ended. I really appreciated the addition of interpretation, however, the Spanish was missing. As said in the conclusion- there were a number of discussions that were started that need to take the deeper dive.
- Translation was great. Organization and support were great. Loved the interactive element of jam board. PHAP and WRC did a great job
- I don't see any space in comments above to provide feedback on day 3 sessions around functioning and governance? One piece of feedback is that I wish the stakeholders WG presentations had been followed by a space for discussion where the WG groups get to ask each other some questions and/or follow up on the priorities shared by each working group, with the goal of identifying common priorities, synergies or opportunities for collaboration.
- Just to reiterate the need for grassroot women participation who are generally victims; the need for a restitution at country level for those who couldn't participate; ownership of initiative by country WLO for effectiveness, inclusion and sustainability





- Virtual events are a huge challenge during these covid times. While I think it might have been hard to get more time from people, only having a few hours over three days made it challenging to dive deep into the topics as we need to continue doing to move CtA forward. Hopefully through follow-up discussions, this won't be a problem in the end, but if we do have to continue virtual meetings far into the future, I would consider adding another day so that timezones can be respected but we also have more time for discussions.
- Better information ahead of time.
- - Please do NOT hold the Annual Meeting in September everything was too last minute, with the agenda only being shared in the second half of August.
  - Better not to start the meeting on a Monday especially a week after the start of the school year for many with children.
  - Denmark's position as lead was not really clear, as there were many points raised during the meeting, which were not responded to in the Danish presentations - including the repeated calls to respond to the Women of Tigray.
  - The mix of Zoom, Jamboard, and Menti with breakout rooms was great to get participation all around, as was the interpretation.
  - Having Spanish interpretation would be helpful next time for Latin American WLOs.
- Less jamboard! More LIVE DEBATE!!
- In general, and I had the same experience last year, three days is just too much when the annual meeting is virtual. Although I think the annual meeting was in theory well planned with break-out rooms and all, I lost concentration in the midst of it. Also, I appreciate the idea of welcoming everyone to moderate sessions, it is vital that moderators know their task well. Especially the first day was hard to get through because of not too experienced moderators. If the format of three days is kept for next year, I would recommend dividing the meeting more into 'key' and 'optional' sessions as otherwise it just becomes painful for everyone.
- Unfortunately it feels like the main, burning issues were neither discussed nor resolved. Solutions were not unpacked in sufficient detail to drive change, and there was not enough discussion. It did not feel action oriented, despite being a call to action!
- Meeting of such nature should be done periodically to keep stakeholders abreast of activity dynamics.
- Maybe in person would feel more clear.
- The timeframe allotted was too short and there should have been a bi ref session for questions and answer.
- Meeting could be reduced to two days. More strategic discussions on how to strengthen the partnership should be prioritized next time. Important with specific high level participation at certain segments.
